





YOUNG ADULTS FROM CARE EXPERIENCED EXPERT PANEL AT THE **CARE EXPERIENCES PROJECT GO-LIVE EVENT, NOVEMBER 2023**



An event celebrating the Care Experiences project new website took place on November 9th at DCEDIY. The celebratory event was attended by a number of professional stakeholders and

members of the Project's Care Experienced Expert Panel (CEEP). The CEEP is a diverse group of young adults who have lived experience of care and who provide advisory input to the Project. A sub-group of members from this panel were instrumental in the design and development of the Project brand and website.

The Care Experiences project is led by DCEDIY, with Tusla as a key partner, and consists of four constituent elements:

1. The ongoing data optimisation of Tusla Case Management: Child Protection, Alternative Care system (TCM CPAC) to dynamically track the individual pathways of children in care;

- 2. A cross-sectional study of those who left care ten years ago;
- 3. A longitudinal study of young people progressing through the care system, which will take place over a ten year period;
- 4. Bespoke research studies on children in care and aftercare.

Title: Working with families at the intersection of domestic violence and abuse and child protection and welfare: challenges and opportunities

Given the established weight of evidence of concern for children's health, well-being and safety when living with domestic violence and abuse (DVA), it is not surprising that these children and their families represent a considerable percentage of child protection and welfare cases in many jurisdictions globally. While Child protection services play a critical role in assessing risk and ensuring child safety for children living with DVA, the existing research evidence highlights many challenges for effective child welfare and protection intervention with families experiencing DVA.

In this Special Issue we invite contributions that reflect on the challenges and opportunities for best practice at the intersection of DVA and child protection and welfare practice. We encourage research papers, practice commentary and reflection, and inter/multi-disciplinary dialogue. Submission are therefore, not restricted to those working in DVA and/or child protection and welfare. Our services are for anyone aged 14 years and over who have experienced sexual abuse in childhood, sexual assault, rape or any other form of sexual violence. NATIONAL PROGRAMME FOR SCREENING AND BRIEF INTERVENTIONS (SBI) FOR PROBLEM ALCOHOL & DRUG USE

One Day Course

This course aims to prepare nurses, midwives, health and social care professionals to implement Screening and Brief Interventions (SBI) for problem substance misuse.

On completion of this course, participants should be able to:

- Apply the theory from the SAOR online module to their practice
- Identify opportunities to conduct a brief intervention
- Demonstrate appropriate brief intervention skills using the SAOR model
- Identify appropriate alcohol and other drugs care pathways

The key course content which emerges from the course learning outcomes is outlined below:

- Evidence for the effectiveness of SBI.
- · Alcohol and drug related presentations to health and social care settings.
- · Contemporary models of SBI for problem alcohol and drug use.
- Overview of the SAOR model of intervention for problem alcohol and drug use.
- Establishing a supportive working relationship with the service users.
- · Asking about alcohol and drug use and screening for alcohol and drug related problems.
- Delivering a structured brief intervention based upon the SAOR model.
- Developing appropriate care pathways for service users and arranging appropriate follow up.
- Accessing useful links and reference materials for further reading and research.

The primary target audience is nurses, midwives and allied health and social care professionals who are in a position to offer Screening and Brief Interventions to service users presenting with problem alcohol and drug use.

What is the effect of intergeneratio nal activities on the wellbeing and mental health of older people?: A systematic review

Intergenerational interventions are activities designed to bring younger and older people together, and may contribute to small improvements in self-esteem and levels of depression in older people.

However, this systematic review shows that it is not clear if these positive effects are consistent or last beyond the intervention. The evidence in this review also suggests that it is not clear if intergenerational interventions have any impact on quality of life, agitation, stress and loneliness in older people. There is no trial evidence looking at the effects of intergenerational interventions on social isolation for older people.

1.1.1 What is this review about?

Mental health and wellbeing, including loneliness, is a huge global issue, shared by younger and older people. The Covid-19 pandemic has increased loneliness for many, with generations being kept apart for safety.

Intergenerational interventions aim to promote greater understanding and respect between generations and help build communities. Intergenerational interventions can take many forms: school children visiting nursing home residents to share activities and stories, younger and older people coming together to share in music-based activities, older people volunteering in schools, and older people from outside the family helping/mentoring students.

This review looks at the impacts of

intergenerational interventions related to the mental health and wellbeing of older people including depression, anxiety, quality of life, self-esteem, social isolation and loneliness. The review also looks at impacts on life satisfaction, agency (a sense of control and desire to do things in life), generativity (sense of purpose/meaning in life), happiness, intergenerational interaction or interaction with others, social activities, self perception, perceived emotional wellbeing, spiritual health, and sense of community.

1.1.2 What is the aim of this review?

This Campbell systematic review describes trials of intergenerational interventions that have reported on the mental health and wellbeing of older people, and how effective they were.

1.1.3 What studies are included?

This review includes 14 trials from six countries: USA, Japan, Italy, Spain, Australia and Canada. Interventions were mainly delivered in person and often in groups. They included visiting programmes, school volunteering programmes, music based interventions and taskoriented interventions such as activities set in a multigenerational park, reminiscing activities, aggression management programmes, learning a language, making local environmental changes and in-school project work.

The trials had some important weaknesses that may have affected their results.

Intergenerational interventions showed a small positive trend towards improving self-esteem and depression for older people participating. However, due to the small study sizes and low number of studies available, we cannot be confident about any effects.

Results for other mental health and wellbeing outcomes are reported. There were no data about social isolation, spiritual health or sense of community.

The lack of consistent outcomes reported and the lack of studies on interventions that are similar or have similar elements means it is difficult to determine if any one intervention or element is effective for any given outcome.

1.1.5 How do these interventions work?

We still know very little about what works and how or why. Whilst some interventions do use known theories or techniques to articulate how something is thought to have an impact, others do not. It is therefore difficult to establish why any particular intervention might have an impact on any particular outcome.

1.1.6 What do the findings of this review mean?

The differences in the included studies means we cannot be certain that the findings are true and consistent across intergenerational activities. We need more robust research with larger numbers of participants who are studied for a longer period and after the intervention. This field of study would also benefit from using agreed outcome measures consistently across interventions, to aid future comparisons and the development of research and practice.

1.1.7 How up-to-date is this review?

The review authors searched for studies up to July 2021 and searched again in June 2023 for new randomised controlled trials.

Psychological interventions for depression in adolescent and adult congenital heart disease

Key message

• Psychological interventions (talking/counselling therapy) may reduce symptoms of depression in adults with congenital heart disease.

• Further studies are required to define the best psychological treatment for this population, such as the duration, frequency, and type of intervention.

What is congenital heart disease?

Congenital heart disease is an umbrella term used to define a range of birth defects that affect the way in which the heart works.

Why is important to do this review?

Sometimes, young adults and adults who are born with heart problems have depression. Besides antidepressant medicine, treatments to help reduce the depression include different types of talking therapies (known as psychological therapy). The benefits of having treatment with talking therapy may include a reduction in depression and improved quality of life, but the treatment may not help relieve the depression.

What did we want to find out?

Our aim was to examine the effects (both harms and benefits) of psychological interventions for treating depression in young adults and adults with congenital heart disease.

What did we do?

We updated the searches of the medical literature to March 2023. We selected studies that met our criteria, assessed the risk of bias for depression, compared the results of these studies, and rated our confidence in the evidence based on these studies (e.g. assessment methods and size of the sample).

What did we find?

We found three studies, with a total of 480 participants with congenital heart disease, which looked at how psychological interventions (talking/ counselling therapy) impacted depression. The psychological interventions lasted between 90 minutes and 3 months. These studies were conducted in Canada, Sweden, and the Netherlands. Studies were funded by grants from the National Research Council of the respective countries.

The results of our review suggest that a psychological intervention may help to reduce the symptoms of depression in adults with congenital heart disease. However, the type and length of the intervention varied between studies, so it may be possible that some interventions may make little or no difference to reducing depression.

What are the limitations of the evidence?

There were only three studies that met the criteria for the review, and the certainty of the evidence was low. There was insufficient evidence to draw conclusions about the impact of psychological interventions (talking/counselling therapy) on quality of life.

How up to date is this evidence?

This evidence is up to date to March 2023.



Cilter is built into the Operating System of the phone so it has access to all data and communications allowing it to effectively detect the signs of potentially damaging content and take action by blocking and informing parents.







The Academic Insights series is aimed at all those interested in research and developments in the evidence base for high-quality probation and youth offending services.




Care Alliance Ireland are pleased to publish a new guidebook for health & social care professionals and volunteers who may be working to support Ukrainian family carers in Ireland.





Racial, social and spatial inequalities: Supporting Black African Students on practice placement using UBUNTU philosophy

Oluromade (Rom) Olusa1

Abstract: This paper, based on a systematic review for a doctoral study, addresses racial, social, and spatial inequalities affecting Black African social work students. It emphasises the dearth of research on challenges faced by these students in Ireland, drawing insights from UK and USA research to underscore attainment disparities. The paper emphasises the holistic and worldview approach and advocates for support from practice educators using my newly created practical tool, which is rooted in the Ubuntu philosophy, to meet the unique needs of Black social work students on placements. Ubuntu translates as, 1 am because we are'. As such, it provides a unique African interpretation of social work education given its holistic and worldview approach to meeting the needs of individuals and groups hence, its uniqueness as an underprinning guideline for supporting Black social work students in practice placement. This article concludes that the practical framework developed by the author, in line with the Ubuntu Philosophy, will enhance the learning and achievement of Black social work students.

This paper highlights racial, social and spatial inequalities that impact Black African social work students. It also considers the implication for Practice Educators in Ireland to address gaps identified from a review of relevant literature. It encourages field coordinators and practice educators to ensure a culturally responsive and supportive practice placement for Black students using the philosophy of Ubuntu, which is underpinned by showing humanity towards others. This practice Note, uses the principles of Ubuntu to support Black African students, a visibly increasing population in Irish social work education. There is limited literature regarding the challenges experienced by social work students and ways of supporting them in Ireland; that which exists deal with issues students commonly experience (Roulston et al., 2021). Literature from the UK and USA reveals that Black social work students experience differential attainment compared to their white counterparts (Fairtlough et al., 2014; GSCC, 2012; Liu, 2017; Mbarushimana and Robbins, 2015). In light of this limited definitive knowledge base, it is necessary to highlight the inequalities impacting Black social work students on placement and how their practice educators can support them to complete and achieve quality learning on placements using the Ubuntu Philosophy. **Click here** to read this paper.


