

The National Perinatal Epidemiology Centre (NPEC) is a national clinical audit and research centre based at University College Cork with offices at Cork University Maternity Hospital and directed by Professor Richard A. Greene.

Our comprehensive approach to audit ensures the quality and integrity of our audit process, ultimately contributing to improved perinatal care.

At the NPEC, we acknowledge that the statistics presented in our reports represent our patients, and we use this data to learn from past experiences and produce recommendations for improved care.

OUR OBJECTIVE

The NPEC's objective is to collaborate with lrish maternity services to translate clinical audit data and epidemiological evidence into improved maternity care for families in Ireland.

OUR AUDIT PROCESS

At the NPEC, we follow a collaborative process in conducting our audits. Here's how we work:

- Coordinators at Every Hospital: the first step is the identification of an audit coordinator at hospital level. This coordinator is a key part of our approach.
- Involving Experts and Stakeholders: Our audits bring together clinical experts and relevant stakeholders, creating a diverse multidisciplinary team. We also include nominations from professional bodies and ensure patient representation in our audits.
- Engaging Maternity Units: Our dedicated Audit Project Manager collaborates closely with unit coordinators, building strong relationships.
- Reports and Outlier Identification: We generate individual reports for each hospital and identify outliers, we align to the National Office for Clinical Audit Escalation Policy when necessary.
- **Site Visits:** We conduct site visits, where the Director and Audit Project Manager/Data Coordinator personally visit every unit.
- Feedback and Improvement: We host study days and feedback forums for continuous improvement.
- Quality Data Collection Tools: Our NPEC Audit
 Data Collection Tools are evidence-based,
 validated, and allow for international
 comparisons, ensuring the quality and integrity of
 our audit process, contributing to improved
 perinatal care.
