Copying from Books, Journals and Periodicals Under the ICLA Higher Education Licence

With effect from 1st January 2004

The ICLA Licensing Scheme

The Licence is issued in accordance with SI 514 of 2002 in relation to the licensing of educational institutions and the terms outlined therein. The Licence covers photocopying from the majority of books, journals and periodicals that are used in Higher Education Institutions. The Licence is an all-inclusive one in that all licensed copying is covered by just one blanket licence and fee. Each copier should have the User Guidelines and List of Excluded Categories & Works displayed on it. A list of mandating American publishers should be lodged with the institution's licensing co-ordinator. This leaflet should be distributed to each member of staff. All ICLA support material can be photocopied free of charge and is available on the ICLA website at www.icla.ie.

Copyright in a Published Work

Publications covered by the ICLA Licence are likely to be protected by more than one copyright. An author's, artist's or photographer's copyright lasts for 70 years from the end of the year of their death. The publisher's copyright in the typographical arrangement lasts for 25 years from the end of the year in which the edition was first published. All copyrights must always be considered. If the publisher's typographical copyright has expired (ie: the edition is over 25 years old), the author, artist or photographer may still be in copyright. Similarly, a new edition (employing new typographical arrangement) of a literary work whose author is out of copyright will be protected by the 25 year publisher's copyright. Therefore, if a work is "out of print" it does not necessarily mean it is "out of copyright".

Definition of copying

Copying by any process, not just photocopying, is limited by the Copyright & Related Rights Act, 2000.

What the Licence covers

The Licence permits the copying of extracts from all books, journals and magazines published in Ireland and 14 other countries (see list below). The main limitations are as follows:

No copying may exceed 5% of the published volume or issue or, if greater:

- one complete chapter from a book,
- or one article from a journal or magazine,
- or a short story or poem not exceeding 10 pages in length from an anthology from any item of Licensed Material.

Only the number of copies required so that each member of the class has one copy each, plus two for the tutor, may be made. The licence also permits the copying onto acetate for use with OHPs. All copying must be from published originals and no systematic or repeated copying of the same material which would breach the above limitations is permitted during any one course of study/module. It is important that these limits are not exceeded or the institution might be at risk from legal action. If tutors which to copy above these limits they should contact rightsholder(s) directly for permission.

The Licence generally overrides the "All Rights Reserved" prohibition to copy notice in the front of most copyright material, unless the notice specifically excludes copying under the ICLA Licence.

Course Packs, Distance Learning, Short Loan Collections

The production of course packs can be made under the blanket licence provided the standard extent limitations outlined above are not exceeded. Similarly, all copying for

flexible or blended learners (covering open and distance modes of study) is included under the blanket licence provided the extent limitations are observed. Licensed copies may only be sold to student at a charge to recoup the cost of production and not for commercial profit.

Artistic Works

Photographs, illustrations and diagrams are only covered by the Licence where they are integral to the text. Stills, advertisements, logos and trademarks may not be copied. For the avoidance of doubt, the Licence does not permit the production of slides.

Overseas Publications

Books, journals and periodicals published in the following countries are covered by the licence through reciprocal agreements: the U.K., Australia, Canada, France, Germany, Greece, Iceland, Malta, books published in English in the Netherlands, New Zealand, South Africa, Spain and Switzerland, a list of the US publishers covered by the licence is published from time to time by ICLA.

The Licence does not cover

- Printed Music (including the words)
- Newspapers
- Maps, charts or books of tables

The Ordnance Survey of Ireland has its own licensing scheme and tutor may copy under the terms of that licence if one is held by the Institution.

- Workbooks, workcards or assignment sheets
 - Defined as publications intended for the student to write on and for once-only use.
- Correspondence Courses
 Generally these are not published works included in the Licence.
- Industrial House Journals
- Includes in-house company newsletters.
- Publications on the Excluded Works List
- Grey Literature

Material which cannot be readily obtained through normal bookselling channels, eg: leaflets, instruction manuals, promotional literature, flyers, etc.

"Copy Permitted" Publications

These are sold either with a licence from the publisher or with authorisation on the source material for onward copying. The extent to which copies can be made is usually indicated on the work.

Electrocopying

No copying or storage of copyright material using electronic means is permitted under the licence. This includes scanning, faxing and retyping from published sources using a word processor or desk-top publishing system. The Copyright & Related Rights Act, 2000 specifically restricts storage and copying by electronic means and any electrocopying must be authorised by the rightsholder(s). ICLA is presently consulting with publishers, authors and users to develop a licensing scheme for the digitisation of text by licensee institutions.

Identification of Extracts

It is good practice that each master copy containing extracts from books, journals and periodicals, intended for copying on and handing out should be identified at the foot of the page with bibliographic details of the source such as **author**, **title**, **publisher** and **ISBN/ISSN** before copying takes place.

Tutors producing worksheets using *cut and paste*, of what may be more than one extract from published material, should identify the source of each extract in the above manner at the foot of each page.

Storage

Copies may be stored for further use but should be identified as above and re-recorded (if required to do so by ICLA) each time they are used or further copied.
