

EU COST Action Workshop on the Burden of Disease Knowledge Translation in UCC

The 4-year project on <u>Burden-EU COST Action</u> started in 2019 and focuses on the exchange of knowledge on methodologies, data handling and the link with policy makers regarding the Burden of Disease approaches. A 2-day workshop on Knowledge Translation (KT) was organised in April 2023 (17-18th) in UCC at the School of Public Health for the members of this COST Action European Burden of Disease Network. A hybrid model was adopted. In total, 31 delegates attended this workshop (four online) from more than 25 countries, including the United States. The workshop's chair Dr Henk Hilderink from RIVM, Netherlands co-hosted this with the local organizer, <u>Dr Zubair Kabir</u> of the School of Public Health, who is the Irish lead on this EU COST Action project, which is coordinated by Professor Brecht Devleesschauwer of Sciensano, Brussels.

The workshop included opening and concluding remarks from the Head of School of Public Health, Professor Ella Arensman, and the Head of College of Medicine and Health, Professor Helen Whelton, respectively. Representatives from 15 countries, including delivered pitch presentations on the progress of Burden of Disease Studies in their respective countries. Dr Christopher Ryan, Head of Research Services and Policy at the Department of Health in Ireland, spoke on "The Global Burden of Disease: Policy Feedback from Ireland". Dr Kuchenmueller, Head of the Tanja Evidence to Policy and Impact Unit at the World Health Organization (WHO) spoke on KT and the newly-established EVIPNet (EVidence-Informed Policy Network) at the WHO. Dr Paul Kavanagh from the HSE Health Intelligence Unit had an insightful presentation on views from the front line on using evidence and information to influence public health policy from an Irish perspective. The workshop concluded with a guided tour of the picturesque spring UCC campus led by Ms Edel Burton of the School of Public Health!

'Mental Health Promotion and Intervention for Occupational Settings' (MENTUPP) Continues to Promote Mental Health and Wellbeing in the Workplace

The European Union's Horizon 2020 research and innovation programme four-year funded project, **MENTUPP**, led by Professor Ella Arensman, recently held the Consortium's project month 42 plenary meeting in a hybrid meeting format. Members of the project within the School of Public Health (Dr Caleb Leduc and Karen Mulcahy) and the National Suicide Research Foundation (Dr Paul Corcoran and Dr Eve Griffin – also affiliated to the SoPH – and Dr Mallorie Leduc) joined colleagues from 18 **MENTUPP** Consortium partners representing 11 European countries, Australia, and the USA, both in-person in Durrës, Albania and online for meetings, discussion, project planning and a writing day from 7–9th June 2023.





The **MENTUPP** Consortium continues to build momentum working through the final year of the project, with the first publication from their pilot trial study highlighting positive results on three long-term outcomes, including mental wellbeing, symptoms of anxiety and personal stigmatising attitudes towards depression and anxiety with worker participation from 25 small to medium sized enterprises in eight European countries and Australia (see: https://doi.org/10.1186/s12889-023-16092-x).

The protocol manuscript for the cluster randomised controlled trial (cRCT), 'Implementation and evaluation of a multi-level mental health promotion intervention for the workplace (**MENTUPP**): Study protocol for a cluster randomised controlled trial' has recently been accepted for publication to BMC Trials. As the cRCT and broader project enters its final stages, the **MENTUPP** Consortium remains committed to communicating and disseminating learnings and findings to promote mental wellbeing in the workplace across a number of academic and applied settings.



Dr Karen Matvienko-Sikar Awarded Flinders University Visiting International Research Fellowship

Dr Karen Matvienko-Sikar was recently awarded a Flinders University Visiting International Research Fellowship. Dr Matvienko-Sikar is a Lecturer in the School of Public Health and a HRB Emerging Investigator and Principal Investigator on the EIA-SCOPE project. Her research focuses on childhood obesity prevention, maternal health and wellbeing during the perinatal period, as well as health behaviours and psychophysiological indicators of wellbeing. Methodologically, Dr Matvienko-Sikar has expertise in intervention development, outcomes research, evidence syntheses and trial methodology.

In April 2023, Dr Matvienko-Sikar was Visiting International hosted Researcher at the Child and Families Research team in the Carina Futures Institute at Flinders University. During her visit, Dr Matvienko-Sikar presented a keynote seminar to staff at the Carina Futures Institute at Flinders University on 'Supporting maternal and child health in the first 1000 days". Dr Matvienko-Sikar also delivered an invited seminar to Wellbeing South Australia, which is a state government agency supporting well-being health and of Australians. Dr Matvienko-Sikar's visit to Flinders University in South Australia facilitated knowledge exchange, enhanced collaboration and fostered professional capacity building and development for researchers and health professionals across multiple institutions.

Summer Masterclass on Implementation Science in King's College London

Dr Monica O'Mullane shares her experience participating in an implementation science masterclass in London this summer.

"I participated in an Implementation Science Masterclass in Kings College London, organised by the National Institute for Health Research Applied Research Collaboration (NIHR ARC) South London. It was a fantastic experience overall. I attended lectures on different aspects of Implementation Science (IS) theories and frameworks. I also attended workshops relevant to my research on Health Impact Assessment (HIA-IM), including one on enhancing equity in IS research and strengthening co-creation in community engagement when using IS frameworks. I found meeting experts in the field really beneficial. Meeting other researchers, and swapping contacts with some, who are doing similar research to me, was such a brilliant outcome of the masterclass too."



New study to begin on problematic opioid use

Dr Michael Congratulations to Hanrahan who has been appointed as a Research Support Officer to conduct a study on problematic opioid use in Working with Principal Ireland. Investigator Dr Seán Millar of the School of Public Heath, Michael will determine the prevalence of problematic opioid use in Ireland for the years 2020-2022 by age, sex, city, Community Health Organisation (CMO) area, Regional Drug and Alcohol Task Force area and regional health area.

Drug prevalence figures are a valuable tool for assessing treatment needs and offer a realistic basis for estimating the social costs of problematic drug use. In addition, the regular production of estimates facilitates the tracking of changes in drug use over time. One of the key methodologies favoured by the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) for determining the number of opioid users in a population is the capture-recapture method.

methodology Capture-recapture useful for estimating the size of hidden populations, such as opioid drug users. It requires the use of two or more independent lists of known drug-users. The degree of overlap between these lists allows statistical models to be created to determine the size of the uncaptured population. For this study, the School of Public Health will draw on data from treatment clinics, GPs, prisons and the Irish probation service. This is the second study to be undertaken by the School of Public Health on problematic opioid use in Ireland. Welcome back Michael and we wish you success on this project!

E-SHEILD: Enabling Students and Higher Education Institutions to Lead the Response on Drugs

The UCC MyUSE Research Group is to receive €293,988 funding over the next three years under the Irish Department of Health's National Drug Prevention and Education Funding Programme. The programme aims to increase the delivery of prevention programmes in Ireland that are supported by evidence and adhere to international prevention standards.

The **MyUSE** Research Group includes Dr Seán Millar of the School of Public Health, Dr Michael Byrne, Head of UCC Student Health, Dr Samantha Dockray and Dr Conor Lineham, Senior Lecturers in the School of Applied Psychology, Dr Ciara Heavin, Professor of Business information Systems, and Dr Martin Davoren, Executive Director of the Sexual Health Centre in Cork City.

E-SHEILD continued

Funding will be used to enact the Enabling Students and Higher Education Institutions to Lead the response on Drugs (E-SHEILD) programme. This programme will support students and Higher Education Institutions (HEIs) to reduce harms experienced through drug use. It also aims to reduce the overall number of students choosing to take drugs. Each participating Irish HEI will be provided with MyUSE, a mobile app/web-based prevention, education and behavioural change intervention that aims to:

- increase mindful decision-making with respect to drug-use,
- · cultivate harm-reduction practices, and
- promote alternatives to drug-use activities.

MyUSE is a new evidence-informed mobile app that has been purpose-developed for students in higher education. Specific evidence-based behaviour-change techniques are delivered via the clinical algorithm contained within the app.

CLIMATEMED: KNOWLEDGE ABOUT CLIMATE CHANGE HEALTH IMPACTS IS HERE

Dr Frances Shiely is Ireland lead on an EU project on the health impacts of climate change. In collaboration with partners in University of Pecs and the National Public Health Center, Hungary, Universitatea de Medicina, Farmacie, Stinte si Tehnologie, Romania and Center for Health, Exercise and Sport Science, Serbia, the **CLIMATEMED** project has four phases, with the ultimate goal of providing an education curriculum on the health impacts of climate change for use in medical schools, and schools of Public Health, across Europe.

Dr Shiely will teach a new module, an output from this project, to the undergraduate BSc Public Health Sciences students in January 2024.

Implementation Research Scientific Conference held in Bilbao





FEAST Presentation at the European Congress on Obesity



The 30th European Congress on Obesity took place in Dublin in May 2023. The Congress was co-sponsored by the European Association for the Study of Obesity (EASO) and the Association for the Study of Obesity on the Island of Ireland (ASOI). Its programme attracted over 1600 delegates from across Europe and beyond over four days at the Convention Centre. SoPH was represented by Dr Janas Harrington, event speaker, as well as by postdoc Margaret Steele, who gave a guided poster presentation on the implementation of the Business **Impact** Assessment on Obesity and Population Health (BIA-Obesity) in Ireland. The poster represents work carried out as part of the EU Farm2Fork FEAST project by Drs research assistant Shannen Harrington and Steele, Hussey and SoPH undergraduate Claire Griffin, who did her work placement in the School over the summer.

BIA-Obesity is a tool and process developed by International Network for Food and Obesity/Non-communicable Diseases Research, Monitoring and Action Support (INFORMAS, www.informas.org) to assess how food industry policies and practices impact the food environment. The aim of BIA-Obesity is to establish a benchmark of food companies' publicly available commitments in the domains of corporate nutrition strategy, product formulation, nutrition labelling, product and brand promotion, product accessibility, and relationships with other organisations. This work builds on the implementation of INFORMAS's Healthy Food Environmental Policy Index (Food EPI) in Ireland, which assessed the impact of government policies and infrastructure. BIA-Obesity is simultaneously being conducted in Portugal and Belgium, and we look forward to presenting a multi-country comparison as well as our final results for Ireland in the coming months.



Royal College of Physicians for Ireland - Faculty of Public Health Summer Scientific Meeting

Jennifer Pallin, PhD student, delivered an oral presentation entitled "Early detection of risk factors for diabetic foot ulceration – does it meet the principles of population-based screening? A scoping review of the literature" at the Royal College of Physicians of Ireland Summer Scientific Meeting. The meeting was held on the 23rd and 24th May. The presentation outlined key findings of a scoping review carried out as part of Jennifer's PhD.




6th UK & Ireland Implementation Research Conference

Members of the Health Research Implementation Hub (HIRH) attended the 6th UK and Ireland Implementation Research Conference, jointly hosted by the Health Implementation Science and Technology (HIST) cluster at the University of Limerick (UL) and NIHR ARC South London. The hybrid conference took place in UL on 13th and 14th July and featured a mix of rapid fire poster presentations, oral presentations, meet the expert sessions, and several excellent keynotes from seminal speakers in the field, including Prof. Enola Proctor – in her talk she reflected on progress in implementation science (see 'Ten years of implementation outcomes research: a scoping review').


The HIRH team presented on several pieces of ongoing work:

- **Dr Jane Murphy** delivered a rapid-fire presentation on a mixed methods evaluation 'Stakeholder's experiences of tailoring implementation of the DAFNE structured education programme for type 1 diabetes'.
- Laura-Jane McCarthy presented a rapid-fire presentation on 'Tailoring implementation strategies which target patients in healthcare contexts: protocol for a scoping review sub-study'.
- **Dr Fiona Riordan** presented on an ongoing Cochrane review 'Tailored strategies to address determinants of practice: A systematic review protocol'.
- Nickola Pallin presented on two studies from her PhD:
 - 'What is needed to implement self-management support (**SMS**) in cancer care delivery? A qualitative study of **SMS** implementation in Ireland'.
 - 'Barriers and enablers to participating in self-management support among those living with and beyond cancer: a qualitative study informed by the TDF and COM-B'.

- ▶ Bearing in mind the challenges, what steps do we need to take to improve services?

NSRF & SPH organised Seminar on 'Impact of Bereavement by Suicide on Adolescents and Parents'

The NSRF and the School of Public Health welcomed Dr Karl Andriessen to UCC on Thursday 25th May.

Dr Andriessen presented on the 'Impact of bereavement by suicide on adolescents and parents', with over 200 people in attendance in person and online.



Core Competency Framework for Suicide Prevention in Undergrad Students presented at the UCC CoMH Learning and Teaching Showcase

Colleagues in the NSRF presented a poster at the CoMH Learning and Teaching Showcase, which took place in UCC on June 16th. The poster was entitled "Developing a national curriculum in suicide prevention for healthcare students in higher education in Ireland".

The module is based on a core competency framework for suicide prevention and aims to provide undergraduate healthcare students with the fundamental knowledge, skills, attitudes and confidence necessary to identify and work with individuals at risk of suicide. This project is currently in the design phase, with pilot implementation and evaluation planned for Semester 2 of the 2023/24 academic year. The project is led by Dr Eve Griffin, Dr Cliodhna O' Brien, Dr Michelle O' Driscoll and Ms Kerrie Gallagher, with valued input from various stakeholders, including student representatives, the National Office for Suicide Prevention, as well as healthcare lecturers and module co-ordinators across Higher Education Institutions in Ireland.

UPDATES FROM THE NSRF

DEPARTMENT OF HEALTH-FUNDED STUDY STARTS, SEEKING TO UNDERSTAND THE MENTAL HEALTH CHALLENGES AND SERVICES NEEDS FOR WOMEN FROM THE IRISH TRAVELLER COMMUNITY



Dr Katerina Kavalidou, Senior Postdoctoral Researcher at the National Suicide Research Foundation (NSRF), and Database Manager for the HSE National Clinical Programme for Self-Harm and Suicide-Related Ideation (NCPSHI) has been awarded Department of Health (DoH) funding.

The study aims to understand the mental health challenges and services needs of women from the Irish Traveller community, presenting to Emergency Departments (EDs) with suicidal ideation. Working on this project are Dr Isabela Troya, Postdoctoral Researcher from the NSRF and UCC School of Public Health, and Lecturer Dr James O'Mahony (Co-PI) from the School of Nursing and Midwifery at UCC.

Self-harm and suicide are major public health concerns, with certain ethnic minority groups being more vulnerable to suicidal behaviour. In Ireland, there are over 30,000 Irish Traveller people (0.7% of all Irish residents), who face multiple health disparities compared to non-Irish Travellers (eg, at least 13 years of reduced life expectancy). Irish Travellers are a high-risk group for suicide, being up to 7 times more likely to die by suicide compared to non-Irish Travellers, with older Traveller men and women having the highest risk of suicidal behaviours compared to the White settled population of Ireland [women over 50 years old: 6.79 (95% CI 4.37–10.57); men over 50 years old: 9.23 (95% CI 5.93–14.39)].

The 8-month project started in April 2023, and will be conducted across 11 EDs in Ireland, that report high prevalence of suicide-related ideation presentations from Traveller women. Based on previous research by Dr Kavalidou and NSRF colleagues, high rates of self-harm and suicide related ideation were found among Irish Traveller women compared to White Irish women (3.04 higher rates for suicide-related ideation and 3.85 higher rates for self-harm). The aim of the current DoH-funded project is to explore the experiences of Traveller women reaching Irish EDs for thoughts of self-harm or suicide. A qualitative research design will be used to answer the study's research objectives, using Interpretative Phenomenological Analysis via in-depth interviews with Irish Traveller women presenting with suicidal or self-harm ideation to the NCPSHI participating hospitals selected. A Lived-Experience/Public and Patient Involvement (PPI) member is also contributing to the study to help provide accessible information in the recruitment leaflets and research outputs of the project, while a narrative review is being conducted to help map all the existing evidence on the mental health needs of Traveller women reaching EDs in a suicidal crisis.

The findings of this study will help understand the appropriate suicide interventions needed for this minority group of women and recommend further policy for suicide and self-harm prevention for Traveller women at the healthcare level.

HRB Primary Care Clinical Trial Network Ireland Funding Success



Dr Karen Matvienko-Sikar was successfully awarded a HRB Primary Care Clinical Trial Network Ireland, Primary Care Research Seed Funding Award. The project, Refining the Health Infant feeding for Infant intervention and implementation strategy: Re-CHErISH, aims to build on previous finding from the CHErIsH intervention. Specifically, it will refine recruitment processes and delivery of the CHErISH intervention to maximise the likelihood of successful future implementation evaluation of the CHErISH intervention. In addition to colleagues from University of Galway, Trinity College Dublin, Flinders University, and the Mallow Primary Healthcare Centre, the Department of General Practice UCC, and the School of Nursing and Midwifery UCC, the project team includes Prof Patricia Kearney and Dr Kate O Neill from the School of Public Health.



Funding success in Core Outcome Sets

Dr Karen Matvienko-Sikar is a co-applicant on a recent University of Liverpool Harmonised Impact Acceleration Account Award: Using a Massive Open Online Course (MOOC) to increase Core Outcome Set uptake and impact. Core outcome sets are agreed-upon, standardised sets of the most important outcomes to be measured and reported in trials in specific health areas. Led by colleagues from the COMET Initiative, this project aims to promote the uptake of core outcome sets using MOOC to provide training to trialists and other users of core outcome sets.



DR FRANCES SHIELY IS A NEW MEMBER OF CREC

In June 2023, Dr Frances Shiely became a member of CREC (Clinical Research Ethics Committee of the Cork Teaching Hospitals) to provide expertise on trial methods and SWATs (Studies Within A Trial). In addition to the School of Public Health, the National Suicide Research Foundation is a Co-Lead in the PROSPERH project.



Data Management in Health Research - You're funded but are you ready to be FAIR?

25th October 2023, Creative Zone, UCC Library

Sonraí (<u>Irish Data Stewardship Network</u>) aims to develop and support data stewardship skills across the national research landscape through raising the profile data stewards, greater recognition of the need for data stewardship, professionalisation of the role of data steward, and knowledge dissemination throughout this emerging community. This symposium is part of a wider project funded by the National Open Research Forum aiming to identify and organise staff engaged in data stewardship through a series of national roadshows.

What does a Data Steward do?

While there is no universally agreed definition of data stewardship, there is a range of tasks and skills that form part of everyday research activities. These can include: research data management planning; metadata creation and application; database management; data curation and preservation; supporting Open Data and the FAIR principles; data infrastructure development and management; teaching and skills development for researchers; open research advocacy; and policy development.

So a data steward supports many tasks associated with the overall research objectives of a project. These activities take place throughout the research lifecycle from planning the research, capturing the data, analysis, report dissemination, to post-project preservation and data sharing.

Who should attend?

On the 25th October, 'data stewards' working in health-focused research are invited to join the conversation. All major funders require engagement with FAIR data management practices. There is also an expectation that the data captured during the research is made 'as open as possible, yet as closed as necessary'. This is set against a backdrop of data protection rights on behalf of the patient and responsibilities on behalf of the researcher where explicit consent for the processing of those personal data must be outlined, obtained and adhered to.

Data Management in Health Research continued

Few job descriptions identify staff roles as 'data steward'. However, data stewardship responsibilities may informally account from 0.1 FTE and upwards in many instances. We encourage any staff therefore with job roles and responsibilities as outlined above to join us on the day.

Programme

The day will comprise of two sessions. In the morning, a national networking event for staff engaged in data stewardship will take place. An understanding of shared activities and roles will be developed which will feed into the establishment of a wider network of data stewards extending to all research disciplines.

The afternoon session will begin with a panel discussion including HRB and SFI representatives on their aspirations for researcher adoption of FAIR data management practices and the maturation of funder policy in the coming years. The day will conclude with invited speakers in the health research space outlining their experiences with respect to FAIR data management and the observed downstream benefits of the intersection between increased data quality and enhanced research integrity.



Registration for the symposium will open in September.






