



Executive MBA students attend Cork City Council meeting and find it ‘enlightening and frightening’



Dr Aodh Quinlivan accompanied his Executive MBA class to Cork City Council on Monday 24 February. The students – who study the ‘Public Sector’ module – had a private meeting with the Lord Mayor of Cork, Councillor Catherine Clancy, at 5:00pm (see picture above in the Lord Mayor’s office).

The students then attended the public meeting of council which ran for a marathon five hours from 5:30 to 10:30pm. In the words of one of the students, the meeting was ‘enlightening and frightening all at the one time.’

Among the items on the agenda was the proposed closure of the North Monastery School which was heavily criticised by all councillors. The meeting eventually was adjourned in controversial circumstances at 10:30 as the Lord Mayor struggled to retain control during an emotive debate on the motion ‘That Cork City Council, on behalf of the people of Cork, call on the leadership of Sinn Féin who may have any knowledge of the final resting place of murdered victims of the Provisional IRA to disclose this information to the Gardai/PSNI immediately.’




March: A Month of Remembrance in the Department of Government

March is always very poignant for the Department of Government as it brings two significant anniversaries. Monday 3 March 2014 marks the 13th anniversary of the death of Patrick O'Sullivan, a BSc Government second year student who tragically lost his life in an accident. We try to keep Patrick's memory alive with an annual essay competition which was won this year by Pádraig Mac Consaidín on the topic, 'Wit and Humour in Politics'.



Tuesday 4 March 2014 marks the 12th anniversary of Thomas (Tom) Whalen III. Tom, the much loved former Mayor of Albany, the state capital of New York, was a visiting lecturer in the Department of Government. Tom established our third year work placement in the New York State Legislature which is a distinguishing feature of the BSc Government programme.

The department's Student of the Year award bears Tom's name and his portrait hangs proudly in the departmental corridor.

Patrick O'Sullivan and Tom Whalen – Never Forgotten

Two great guest lectures on the MBS International Public Policy and Diplomacy



The MBS International Public Policy and Diplomacy hosted a guest lecture by Commander Patrick Burke on Wednesday 19 February, entitled 'Ordered Chaos: Law on the Battlefield – Is Lawfare the New Warfare?' Commander Burke is a Defence Forces Legal Adviser currently attached to 1 Brigade, Collins Barracks, Cork. As a naval officer he has held various appointments ashore and afloat including command at sea and Legal Officer Naval Service during 'Operation Seabight' which was the largest interdiction of cocaine at sea by the Naval Service. He has served as a Legal Adviser for over 12 years and has deployed overseas to missions in Bosnia, Chad and Lebanon. He has also acted as Legal Adviser to Irish units deployed in Kosovo and Liberia. Pat has completed courses in the law of armed conflict with the International Institute of Humanitarian Law in Italy, the UK Land Warfare Centre, the US Naval War College and the University of Liverpool. He has lectured previously at UCC for the Law Department on the law of the sea and the law of armed conflict. The lecture focused on lessons from Pat's experiences in the field and the emergence of 'lawfare' as a concept to hold parties to armed conflict accountable for their actions.

The following Wednesday saw a lecture by Michael Verling on the topic 'Peacekeeping, Peacebuilding and Election Monitoring: Experiences from the Field.' Michael Verling, a former senior Army Officer, served for two years in Croatia as an official and a human rights monitor for the Organisation for Security and Cooperation in Europe (OSCE). Following Croatia he was offered a UN post in Kosovo/a with UNMIK as a Municipal Administrator for the Self Government of Kosovo/a. He was in the Army for 40 years, serving in Cyprus, Egypt, Israel, Afghanistan, Pakistan and Lebanon. Following retirement as Commanding Officer of the 1st Field Artillery Regiment he completed his MA at University of Limerick and immediately started to work in Croatia. He has lectured at UCC for the Department of Government on the Middle East, the Balkan conflict and democratisation. He has also served as an international election monitor in a number of countries, including Ukraine. The lecture focused on lessons from Michael's experiences in the field.
