The range of awards presented reflects the work of the College, its mission, its relationships, and its history. For example, today a recipient will receive The Peel Memorial Prize, one of the most historic in the University. In 1861, Sir Robert Peel, then Chief Secretary for Ireland, initiated a fund to augment the endowments of the Queen's Colleges. Queen's College Cork subsequently became University College Cork at the start of the last century. This endowment continues to recognise the achievements of our students in what is now a very different world, with its own opportunities and challenges.

For all Award recipients, today's recognition is testament to your excellence and to the development of graduate attributes reflective of the University's core values. We congratulate you and wish you every success. Those now leaving UCC are encouraged to stay in touch with your lecturers, programme staff, and fellow students. Membership in the Alumni Association will help keep you current and connected with the College and University, as we go from strength to strength with your support.

Gala Moot and James D. Donegan Memorial Prize


This year's School of Law, Annual Gala Moot took place on 11 March 2024 in Washington Street Courthouse.
