"Need more OTAs!": OTAs Role within the ASU

1. Introduction/ Background

Only 38% of stroke survivors are getting the recommended levels of occupational therapy whilst in the acute setting (National Office of Clinical Audit, 2022). A potential avenue to explore with regard to improving the functioning of occupational therapy services within the acute stroke unit (ASU) involves the employment of occupational therapy assistants (OTAs). Limited evidence is published on the role of OTAs internationally, with no evidence found regarding the impact of OTAs within ASUs.

2. Research Question

Question:

What is the perceived role and impact of OTAs in relation to service delivery within acute stroke units in the Republic of Ireland?

Sub-Questions:

- To examine what tasks are being undertaken by OTAs in the ASU
- To examine the perceptions of OTs towards OTAs
- To examine OTs satisfaction with the use of OTAs in their profession

Methodology: Quantitative Descriptive

Approach

Participants: 22 OTs working in ASUs

7 OTAs working in ASUs2 Occupational Therapy

Managers

Data Collection: Online Survey

Data Analysis: Univariate Descriptive

Statistics

Ethics: Approval UCC Clinical Therapies Social

4. Findings

Presence of OTA

- **59%** had an OTA
- 27% had a generic therapy assistant
- 14% had no therapy assistant

1. OTs with OTAs

100% of OTs feel OTAs beneficial


91% of OTs confident in delegating tasks to OTA

27% of OTs satisfied with use of OTAs

2. OTAs

19 Hours – Avg. time OTAs spend in ASUs

Tasks completed by OTA include:




3. OTs with no OTAs

3-15 Hours - OTs spend completing tasks that could be completed by OTA

100% ASU services reported they would benefit from addition of OTA

5. Discussion

- First study to describe the perceived impact and role of OTAs in ASUs in the Republic of Ireland and the tasks currently completed by ASU OTAs.
- There are many tasks within the ASU that OTAs could be completing but delegation is not happening potentially due to a lack of clarity surrounding the OTA role.
- Overall, the results indicate there are many benefits of OTAs to the ASU, however, OTs feel that OTAs could be better utilised within the ASU.

6. Implications for OT Practice




There is potential for OTAs to complete a large range of tasks reducing burden on the OT and allowing OTs to focus on more complex tasks
