## School of Pharmacy PhD STUDENTSHIPS APPLICATION FORM

This PhD studentship provides outstanding scholars with the opportunity to direct their own research project at the early-career stage, working with a supervisor in the School of Pharmacy, in a pharmacy specific research discipline.

- The PhD student to be funded by this studentship must have a first class or upper second-class honours degree in pharmacy or a cognate discipline. All applicants whose first language is not English must provide evidence of English language proficiency. The minimum English language requirements currently accepted at University College Cork are available <u>here</u>. The *successful applicant* will have to submit a formal application through the University application system where qualifications will need to be validated. The prospective PhD applicant to be funded by this studentship must all meet all entry requirements for registration as a PhD student. <u>How to Apply | University College Cork (ucc.ie)</u>
- The prospective PhD applicant must submit a personal statement. The personal statement is an opportunity for the candidate to present their goals, experiences, and qualifications. The candidate should also highlight their credentials and suitability for the scholarship, which should ideally include reference to their track record at applying for alternative PhD scholarships e.g., if the applicant has previously applied to IRCSET.
- A research proposal with the potential to benefit the SOP and align with the School/UCC's research priorities are strongly encouraged. Specifically, the research project should emphasise how the outcome will contribute to existing knowledge in the field of Pharmacy related research.
- The primary supervisor must be based in the School of Pharmacy. Applications, where the primary supervisor is at lecturer grade will be prioritised with a view to towards fostering leadership supervisory experience of staff in the School.
- A Letter of support<sup>\$</sup> from the primary supervisor is required stating (i) agreement to supervise the PhD student if they are successful and (ii) how the supervisors/co-supervisors are committed to promoting internationalisation activities in accordance with the FUE-UCC cooperation agreement. In addition, the letter of support should outline (a) how the proposed project aligns with the School's and/or UCC strategic research goals (b) Track record and research potential of the applicant.
- The PhD student funded under this award will be expected to register 100% with the School of Pharmacy. The successful candidate is expected to demonstrate during the SOP Summer School sessions to International Students, and to contribute to other teaching activities within the School of Pharmacy, as part of their stipend.
- The PhD scholarship is for €28,030 per annum (to cover fees, stipend and/or consumables) for up to 36 months maximum. Funding for shorter periods of up to 12 or 24 months may also be considered (e.g., current registered PhD who are self-funded) once justified in the application.


