


The ceremonial mace was commissioned in 1910 to be a suitable symbol of UCC as part of the 1908 National University of Ireland. The Latin inscription on the stem translates as:

"the pious friends and alumni of University College Cork gave me as a gift to their Alma Mater in the year of Our Lord 1910, during the Presidency of Bertram Windle. Egan and Sons, Silversmiths of Cork, made me."

At every conferrings ceremony, graduands receive their degree across the head of the mace, a potent symbol of UCC friends and alumni giving back to the next generation.



Celebrating the past, enriching the present, shaping tomorrow.

From the earliest days of our history individual philanthropic support has helped UCC fund its vision, and many continue to have an impact on campus today.

The Blayney Prize – 150 Years of Supporting Future Doctors

One of the longest established prizes is the Blayney Prize. Lord Blayney died in 1874 leaving bequests to the three Queen's Colleges of Belfast, Cork, and Galway. Today the annual Blayney Prize in UCC is awarded following the results of the Summer Final Medical Examination to a graduand in the College of Medicine and Health.

Edward and Matilda Ryan Scholarship – Immersing Students in the Learning of French

In 1910 Mary Ryan was appointed Professor of Romance Languages at University College Cork, becoming the first female Professor in Ireland. She was a trailblazer in education, pioneering the way for female academics. Professor Ryan's legacy endowed "the summer holiday scholarships" whereby students were awarded scholarships to study French in France for short periods. Still awarded today, these scholarships are named after her parents. Edward and Matilda.

The Honan Chapel – A UCC Icon of Generosity

More well known on campus is the Honan bequest which built and furnished the cherished Honan Chapel, where many alumni have worshiped - and wed - over the decades. The Honan scholarships, awarded in 1910-1911, are noteworthy as the first scholarships of their kind,

providing university education to those without the means to pay for it, marking the beginning of our widening access pathway into higher education.

The Honan bequest also enabled the building of the Honan Hostel, the Biological Institute, and the hydraulics laboratories in the Department of Civil Engineering.

O'Shaughnessy Scholarship Fund – Building a Pipeline of Engineers

In the early 2000s, Elizabeth
O'Shaughnessy's legacy established
the O'Shaughnessy Scholarship Fund
in memory of her grandfather Michael
Maurice O'Shaughnessy, to be awarded
to students in Civil, Structural, and
Environmental Engineering. Michael was
a civil engineer and the San Francisco city
engineer from 1912 to 1932. He developed
both the San Francisco Municipal Railway
and the Hetch Hetchy water system which
brought water from Yosemite Valley and
the Tuolumne River into San Francisco.

Elizabeth Shorten Fund – Supporting Vital Medical Research

Elizabeth Shorten's gift
was deeply personal. She
studied Nursing in the
UK, married her husband
Nill, and joined the NHS. She returned to
Ireland to become Ward Sister in charge
of the Cardiotherasis Ward working with

Nill, and joined the NHS. She returned to Ireland to become Ward Sister in charge of the Cardiothoracic Ward, working with Mr Maurice Hickey, the first cardiothoracic surgeon appointed in Ireland. They were a formidable team and all the nurses she trained were grounded in the number one priority: patient care. Her legacy to Cork

University Foundation for the cardiac department underpinned her appreciation of the affiliation between Cork University Hospital and the University. Today, her legacy funds a groundbreaking research project by Gerry Allen, an Advanced Nurse Practitioner and PhD candidate in CUH/UCC's Cardiology Department who is developing state-of-the-art analysis of the crosstalk between inflammation and cardiac resident cells; a first-of-its-kind project involving human subjects.

Sidney V. Regan – Enriching Current and Future Musicians

Generations of musical talents learned their craft in Cork. British master builder Sidney V Regan moved Leeside in the 1960s where he and his wife, Hilda, enjoyed the local music scene and met Aloys Fleischmann, a professor of music, who would become a lifelong friend. Upon his death, Sidney left a bequest to the Department of Music that enables it to provide direct support to students in the form of scholarships, improve physical resourcing for performers, composers and the academic study of music, and further enable the department to bring in outside expertise. Today, student musicians at UCC are still benefiting from the Regan bequest, which will nurture and develop Cork's future musical talent in perpetuity.

Notifying UCC of your Legacy Gift

Whatever your priority, your will is a private document. If you choose to inform us, in confidence, of your intentions, it will help us ensure your desires are fulfilled properly. The conversation is non-binding, and you can change your will should your circumstances change.

Your gift is as unique as you

UCC is a global university and so are our alumni and donors.

We welcome support from near and far and recognise that every country has unique tax and philanthropy law.

Any gift of cash, stocks, shares, or property could reduce the tax burden on your estate.

Here are types of legacy gifts and sample language from the most common countries we receive donations from. Your legacy gift should be tailored to your individual circumstances and we strongly recommend that you take professional advice from a solicitor when making or changing your will.

Residuary Legacy

This is a percentage or fraction of your estate after taxes, charges and other legacies have been settled to other beneficiaries.

Pecuniary Legacy

This is a specific amount of money and the most straight forward type of legacy. You may wish to discuss with your advisor how to index-link and protect the real value of your gift from inflation.

Specific Gift

You may stipulate that particular securities or other assets are left such as land, shares, property, copyrights or artwork.

Ireland

The following wording may be helpful wording to discuss with your solicitor:

'I give Cork University Foundation - Registered Charity No. 20033385 [the sum of €_/_% share of my residuary estate / the item(s) specified] for its general charitable purposes and I declare that the receipt of the treasurer or other proper officer shall be full and sufficient discharge for the said legacy.'

If you would like to be more specific about how your gift is used, then please add the following wording:

'I express the wish, without creating any trust or imposing any other legally binding obligation, that preference be given to [INSERT YOUR PREFERENCE – the following are examples for illustrative purposes...medical research in ageing / research in APC Microbiome Ireland / undergraduates studying social sciences /postgraduate students in Access UCC Plus]'

United States of America

Gifts in US Dollars (\$) to Cork University Foundation are made through the Chapel & York US Foundation, who then make payments to Cork University Foundation for the benefit of UCC. USA taxpayers should contact foundation@ucc.ie for details on how your legacy gifts can be made to a specific area in UCC. The following example may be tailored to best suit your financial circumstances. To create a bequest for immediate use, the preferred phrase is:

'I give (\$__ dollars) or (__ % of my estate) to the Chapel & York US Foundation, Inc., a 501(c)(3) a Tax-Exempt Organization, EIN 81-2161937, for Cork University Foundation for its general purposes.'

Canada

If you are resident in Canada, notifications should be sent to Cork University Foundation. A bequest to University College Cork is deductible for estate tax purposes, and there is no limit on the amount of the estate tax charitable deduction. The suggested wording of a Canadian bequest is:

'I direct my Estate Trustee to transfer as a gift to University College Cork (an educational institution specifically designated for charitable donations under the Income Taxes Act (Canada) and Regulations [Section 3505] thereto) (the sum of \$_____) or (_____% of my estate), to be used for the benefit of University College Cork.'

United Kingdom

Gifts in UK Sterling (£) to Cork University Foundation are made through the Chapel & York UK Foundation, who then make payments to Cork University Foundation for the benefit of UCC. UK taxpayers should contact foundation@ucc.ie for details on how your legacy gifts can be made in regard to a specific area in UCC. The following example may be tailored to best suit your financial circumstances. To create a bequest for immediate use, the preferred phrase is:

'I give (£__ pounds) or (__% of my estate) to the Chapel & York UK Foundation, registered charity number 1172653, for, for Cork University Foundation for its general purposes.'
