The provisions of the Recast Regulation on Court to Court and IP to Court Co-Operation

 Articles 42- 44- relate to insolvency proceedings, main, secondary or territorial concerning a single debtor

 Articles 57-59- relate to insolvency proceedings relating to two or members of a group of companies.

Add Preventive Restructuring

- Ireland: Examinership (1990 Companies (Amendment) Act, Companies Act 2014 Part 10)
- France: Sauvegarde (Loi no 2005-845 du 26 juillet 2005 de sauvegarde des entreprises)
- Netherlands (CCA 1, 2017, stalled pending ECJ decision)
- Spain: (Royal Decree Law 4/2014, 7 March and Law 17/14, 30 September)
- Austria: (The Company Reorganisation Act 1997)
- EU: At present still styled the Proposed Directive 2016/0359
- UK: Schemes of Arrangement (2006 Companies Act Part 26)
