# **Introduction**

Ballinora and District Community Association (BDCA) was established in 2012 in response to a parish-wide survey that identified eight areas of concern for local residents. Those eight areas were as follows:

- 1. Culture and Heritage
- 2. Social Inclusion
- 3. Environment
- 4. Safety and Security
- 5. Roads and Road Safety
- 6. Communications
- 7. Recreation
- 8. Infrastructure

Since 2012, BDCA has compiled Action Plans based on the eight themes outlined above to assist with progress on community projects. BDCA has achieved remarkable success since its founding in 2012 with numerous projects completed. These include, a text alert programme, a heritage trail through sixteen locations of interest in the area, an impressive and regularly updated community website, biodiversity projects, and restorations of historical sites to name a few. The community association is representative of what is good about a thriving rural Irish community and their unending commitment to improve and serve their local parish is testament to their members. In Rural Ireland (1965), it is the kind of parish that Muintir describes as a "community, and wishes to bind together, with everything focusing on the little central village for communal activities".

The association is led by dedicated, voluntary, elected members, and at the outset of this project in May 2021, was seeking to reassess its activities and practices in the area at a time of unprecedented challenge during the Covid-19 pandemic. The purpose of this research is to conduct a general audit of the activities of the community association, to identify useful and innovative practices utilised by other community organisations, and to provide feedback and recommendations to Ballinora and District Community Association. This project aims to contribute to the long-term survival of BDCA and identify areas where they can improve and strengthen.

# **Community Associations in Ireland**

There are numerous websites run by various organisations that offer conflicting figures for the number of community organisations in Ireland. While the entire non-profit sector accounts for over 30,000 organisations (Benefacts, 2021), it is more difficult to source accurate figures for a breakdown in those numbers. For example, a database of solely rural-based Irish community organisations would be helpful. The regulatory landscape around non-profit organisations is also difficult to negotiate, and has several, thick layers of bureaucracy, with the Charities Regulator also failing to maintain a categorised list of non-profit organisations. In any case, a comprehensive 2020 report by benefacts ie estimated the entire sector to be in excess of 30,000 members but in that same report noted the following:

Missing from our financial analysis of the sector are more than 22,484 local nonprofits. These are mostly schools, parishes, associations and clubs (including <u>unincorporated charities</u>) which don't publish accounts or for which there is no regulatory source of publicly available financial data.

Benefacts.ie used more than 40 sources of data to compile their report which itself suggests the need for a reliable and regularly updated database of community organisations in Ireland. (Benefacts, 2021). While various databases exist, there is little consistency, and a database of specifically rural-based community organisations would be a helpful resource for researchers and community organisations themselves.

## **Ballinora and District Community Association**

#### **Summary of activities since 2012**

BDCA was formed in 2012 and its first project – in consultation with SECAD and UCC was to conduct a parish-wide survey to gain an understanding of the issues of concern to those living in the area. The results were collated and 8 key topics were identified:

- 1. Culture & Heritage
- 2. Social Inclusion
- 3 Environment
- 4. Safety & Security
- 5. Roads and Road Safety
- 6. Communications

#### 7. Recreation

#### 8. Infrastructure

Upon completion of the community survey, annual action plans have been compiled by BDCA since 2012 to ensure continued community development in the eight key areas of concern for residents. In addition, a community website was launched in 2013 and has been regularly upgraded with a dedicated administrator appointed in 2021. Between 2013 and 2021, funding has been received from local donations, SECAD and Cork County Council amounting to €110,000. This is a significant amount of funding which showcases local governments commitment to rural community development. BDCA also participated in the Community Employment Scheme and supported the formation of the Tidy Towns Committee and the Retired Mens Club. BDCA also provide support, insurance and funding when possible to the Tidy Towns Group. Since 2012, in association with UCC, a number of projects have been carried through CARL (community academic research links) to assist the work of BDCA from a research and academic standpoint. BDCA also maintains regular engagement with Cork County and City Council officials and elected representatives to ensure essential roadworks are completed. Through Cork County Council's Village Renewal Scheme, several works have been carried out in the villages of Ballinora and Waterfall to improve roadside fencing and to clear areas for planting with flowers and shrubs. A major project was undertaken to improve the visual appearance of Ballinora and Waterfall with flowers planted in hanging baskets, flower baskets erected on bridges, flowers planted in half barrels, and other measures to improve the visual appearance of the area. Wilding areas have been set aside throughout the parish to create bee friendly environments and the use of herbicides and pesticides was discontinued. A mural was also painted on the school wall at the entrance to the GAA pitch in Ballinora, depicting the major events in the parish since 1199.

Interpretative signs have been erected in Ballinora, Waterfall and Inishkenny graveyards and a heritage trail has been identified and mapped. Sixteen plaques explaining the history of the various focal points along the trail have been put in place and public seating was installed in a number of locations along the trail. BDCA, in collaboration with the Retired Men's Club, cleared the historic graveyards at Inishkenny and Corbally and are presently being maintained on a regular basis with a stone stile built under supervision of the Heritage department at Cork Council to provide access to Corbally graveyard.

Name stones have been placed at the entrances to Ballinora and Waterfall villages and at a number of cross roads. Over twenty finger post signs have also been installed throughout the parish. "Walkers on the road" signs were installed on roads around the parish to alert motorists to drive carefully, electronic speed signs were installed in Waterfall and Curraheen, and a text alert system was established to improve security in the area.

Improved lighting and a footpath were installed in Ballinora village, the school and church walls have been painted and two electronic traffic calming signs were installed at both sides of the school as increased security measures to alert motorists to the presence of schoolchildren.

BDCA, in collaboration with Ballinora Tidy Towns built a stone wall near Waterfall railway bridge. Working with Wildworks, BDCA has prepared a local digitised habitat map to Fossitt Level 3 as part of a 5 year nature and biodiversity plan. The ultimate objective of this project is the preparation and implementation of a Biodiversity Action Plan (BAP) for the Ballinora/Waterfall area. A bat study is also currently underway.

Future projects include a walkway between Ballinora and Waterfall villages, a footpath from Waterfall village to the GAA pitch in Ballymah, traffic calming signs on roads throughout the parish and so on.

# Methodology

For the purpose of this project, a qualitative method is used to gather and collate feedback, via a limited online social survey, from key stakeholders in Ballinora. This survey is used in tandem with a literature review to identify best practices and areas for improvement that may benefit Ballinora and District Community Association. Internet research methods using online methods of communication such as email are useful in a number of ways. They are economical in terms of time and money, distance is no problem, and data can be collected and collated very quickly. (Bryman, 2012: 658).

The method of administering the online social survey for this project was via email. The web survey was attached to the email following an introduction to the questionnaire in the body of the email. The web survey was constructed using a secure google form which was only available to participants who directly received the email from the researcher. One of the main advantages of the web survey is that they can be designed so that, "when there is a filter question (for example, 'if yes go to question 12, if no go to question 14'), it skips automatically to the next appropriate question". (Bryman, 2012: 671).


Due to the ongoing Covid-19 pandemic, administering a wide-scale community survey would present enormous challenges in terms of individual access to internet, computer skills of older participants, and the ability of the researcher to accumulate emails for a large population. In person surveys were not feasible given current pandemic restrictions. The survey was sent, via email, to 23 'key stakeholders' in the Ballinora area. These key stakeholders were identified through their activity in other Ballinora and district based organisations at the community level. Also included in the survey are current members of Ballinora and District Community

Association. The primary aim of focusing on this select group is to generate responses from those members of the community who are actively involved in both the BDCA and other community, sporting or other Ballinora based organisations.


As with all online surveys, the researcher is presented with sampling issues and limitations on the data collected. "A major issue and limitation is that not everyone in any nation is online and has the technical ability to handle questionnaires online in either email or Web formats". (Bryman, 2012: 673). This issue was overcome by focusing on key stakeholders via interorganisational survey administration. This allows the researcher to generate feedback from a population of particular relevance to the project being undertaken. Additionally, most people actively involved in organisations will generally be computer literate and "familiar with the details of using email and the internet". (Bryan, 2012: 674).

# **Survey Results**

This survey formed part of a wider audit of the activities of Ballinora and District Community Association and was used to generate feedback from stakeholders in other Ballinora and district based organisations. The purpose of this survey was to help the researcher and BDCA gain a broader understanding of the perception of the activities of the community association, and to assist in the formation of a successful and sustainable future strategy in the community.





















# **Analysis**

While the survey results should not be considered as having a wide representation of the views of the wider community, there are several examples of areas where BDCA can benefit from a narrower and more focused survey. The survey was sent to 25 people of which 18 responded. The respondents are, in all cases but 1, active members of various different organisations within the Ballinora and district area. The primary areas of improvement identified from the survey are within community engagement, communication, and BDCA's efforts to get the wider community actively involved as stakeholders in their area.

There are several examples of each of these three categories being raised in the comments and in the answers provided to the survey questions. As we can see from the results, over 55% of respondents recall receiving an information flyer from BDCA and of those respondents, over 85% would like to see more frequent circulation of flyers to residents of the area. One area of interest for BDCA is recruitment and a broadening of their activist base. It is best practice for organisations of a voluntary and rural nature to encourage a wide range of age demographics to be actively involved in the running of the organisation. BDCA could appeal to younger demographics through the selection of projects that would appeal more specifically to younger residents.

The key takeaway from the survey is the need for more engagement with the community from BDCA. This is, of course, not without its own challenges in the era of Covid-19. There are many innovative ways that this can be improved such as through establishing an active and

conversational presence on social media platform where community groups can specifically be created for residents of Ballinora to communicate directly via these platforms. These have been used to great effect by other organisations and immediately increase awareness of BDCA and engagement with the wider community.

## **Conclusion**

Ballinora and District Community Association is an excellent example of what an effective rural community organisation can be with enough dedication and hard work, particularly from a core group of members who share the same goal. BDCA are always seeking to improve and evolve in their community. There are, of course, always ways in which you can improve. There are innovative solutions to almost every issue an organisation will face. For BDCA, the most important areas for improvement, in my view, are as follows:

- 1. Undertake initiatives in response to the above survey. Couple this with a full community survey in 2022, which will be 10 years since the previous community survey.
- 2. Diversify funding sources. BDCA has so far relied largely upon funding from local authorities. While this is often adequate for community organisations, there are over 500 other funding bodies active in the NGO sector in Ireland. Many of these bodies provide funding for specific projects and specialised, target funding for local initiatives. BDCA can exploit many of these opportunities simply by analysing the databases available online. These are provided in the bibliography.
- 3. Appeal to younger people. This is somewhat tied to point 2 above because a great way to engage younger people in the community is by embarking upon initiatives that younger residents can have a more active role in. For example, BDCA could apply for grant specific funding to build a tennis court or basketball court. This would increase the awareness of young people towards the association and give them some 'skin in the game' to coin a phrase.
