

Masters in Freshwater Quality Monitoring and Assessment UNEP GEMS/Water Capacity Development Centre (CDC) Bursary

Each Bursary is worth €500 and can be awarded to students from developing countries who have been approved by the UNEP GEMS/Water Global Programme Coordination Unit (GPCU) and applied to commence the MSc in Freshwater Quality Monitoring and Assessment in September 2021. Awards to the value of the tuition fees for Year One will be paid directly to the Fees Office of University College Cork. There may be a possibility of further financial support for Year Two/Year Three depending on the progress made by the student and on the availability of funds. Students will need to meet the following criteria to be eligible for a bursary:

- The applicant must have applied and been accepted for the MSc in Freshwater Quality Monitoring and Assessment.
- Each applicant must have provided an application for reduced fees to UNEP GEMS/Water CDC and have been approved by UNEP GEMS/Water GPCU for reduced fees.

Meeting the criteria above does not guarantee an applicant an award.

Applicants should complete the statement below outlining the significance of undertaking the MSc in Freshwater Quality Monitoring and Assessment and the potential benefit to their organization as a result of the applicant completing the course. **Bursary applications** can be sent to the UNEP GEMS/Water CDC email address (gemscdcadmin@ucc.ie) **before 31**st May 2021.


Application Process

Step One:

Submit your application for reduced fees to gemscdcadmin@ucc.ie. You can find the application form here: https://www.ucc.ie/en/gemscdc/onlinecourses/

Step Two:

To apply for the MSC in Freshwater Quality Monitoring and Assessment you will need to go to the following link: https://www.ucc.ie/en/apply/. Click on **Apply Now** and create an account. Once you have created your account, you can apply for the MSc:



Upload all the relevant documentation in your application. Please, be aware of the entry requirements for the course (https://www.ucc.ie/en/ckr17/). You do not need to pay the application fee at this stage.

Step Three:

Please send the completed bursary application to gemscdcadmin@ucc.ie before the 31st May 2021.

Step Four:

Once you have uploaded all the necessary documentation required for the MSc and sent the application for reduced fees and bursary, the UNEP GEMS/Water CDC can send you a code for the application fee on the system to be waived.

Please Note, the bursary is a competitive process, and you will be contacted in July by the UNEP GEMS/Water CDC team as to whether <u>you have or have not</u> been successful.
