6. Review of Committee Roles in light of recent University's equality structures developments

In September the UCC Equality Committee was disbanded in its current capacity, to make way for new structures in line with HEA reporting, outlined in the EDI strategic plan for next 5 years. There will be one overall equality working group under ULT, and five sub-groups for different areas mandated by the HEA. ULT mandates that staff network chairs/co-chairs will receive automatic membership of the overall equality working group.

This has implications for the roles of our network's committee members, and in particular the role of the LGBT+ Network Staff Liaison Officer. The main responsibility of this role in the recent past has been membership of the now disbanded university Equality Committee. CM thanked the acting LGBT+ Network Staff Liaison officer, LD, for his work over the years and outlined the rationale for the motion proposed in Section 7 below. LD responded with his perspective on this issue.

7. Vote on Motion: "In light of the changing university equality landscape, is there a necessity for the role of LGBT+ Network Staff Liaison Officer?"

10. AOB

Appendix 2: Treasurer's Report

Date of Report: 27 November 2024

Context of Report: This report has been prepared for the 2024 Annual General Meeting of

University College Cork's LGBT+ Staff Network.

Report Notes: This report provides oversight of the financial transactions for the

university's financial year (1 October 2023 – 30 September 2024).

Income Sources: The LGBT+ Network has until now been funded via three ways:

1. Individual event costs are now covered via the EDI Unit e.g. refreshments for Culture Night, Together with Pride merchandise, the Presidents' Afternoon tea as events arise. On behalf of the Network Committee, I wish to acknowledge this support.

- 2. The Network was granted a €1200 grant from UCC's Staff Sports and Social Club during the academic/financial year 2034-24. On behalf of the Network Committee, I wish to gratefully acknowledge this support and to acknowledge the voluntary work that Mary O'Rourke, Network Member, completed during some of this academic year with SSSC as a token of our appreciation for this support. The SSSC and the Network encounter insurmountable challenges in enabling a drawn of the grant because the Network does not have a cost code under Agresso. Until this year, an EFT was made from the SSSC to the Network's Bank of Ireland account. This was not possible this year due to more stringent financial procedures. As treasurer, I will continue to liaise with UCC Finance and SSSC to establish the possibility of a mechanism to receive and use any grant from the SSSC in the future.
- 3. The final source of financial support comes from voluntary membership fees where staff members agree to contribute to the Network's Bank of Ireland Current account via €2.50 per month salary deductions. On behalf of the Network Committee, I wish to express gratitude to members for same.
