What's QACEP?

What's QACEP main aim?

Context and Needs

Continuing Education provided at Higher Education Institutions

Advanced knowledge-based societies require innovative and creative educational systems that are able to answer immediately to specific needs of the continuously evolving and changing labour market.

Higher Education Institutions (HEIs) are key actors in lifelong learning promotion and they are called to implement their efforts in providing research-based higher education for lifelong learners and in guaranteeing the quality of their learning offer.

One response HEIs actually give to social challenges in terms of lifelong learning need is the provision of advanced Continuing Education and Training Programmes, mainly addressed to post graduate but also to secondary students with professional experiences.

Adapted approach for the quality assurance of HEIs Continuing Education Programmes

The growing number and relevance of continuing education programmes (CEPs) determines the need to include them in the quality assurance systems already in places.

An adapted approach for the quality assurance of CEPs is crucial considering the specific objectives of these programmes, the specific target groups, the variety of stakeholders involved, their specific relationship with labour market and society, the great variety in terms of duration, learner target groups, organization, the lack of consolidated and long tradition and sometimes a lack of consolidated rules, national regulations or guidelines for this kind of programmes.
